



CLUB - 2 - CLUB COMMUNICATION

SOUTHERN ARTISTIC GYMNASTICS ACADEMY RECOGNISES THE IMPORTANCE OF MAINTAINING PROFESSIONAL, RESPECTFUL, AND APPROPRIATE COMMUNICATION WITH OTHER CLUBS, ACADEMIES, ORGANISATIONS, AND GOVERNING BODIES WITHIN THE GYMNASTICS COMMUNITY.

PROFESSIONAL CONDUCT

ALL COMMUNICATION BETWEEN THE ACADEMY AND OTHER CLUBS OR ORGANISATIONS MUST REMAIN PROFESSIONAL, RESPECTFUL, AND APPROPRIATE AT ALL TIMES. THE ACADEMY WILL NOT TOLERATE COMMUNICATION THAT IS ABUSIVE, MISLEADING, DISCRIMINATORY, AGGRESSIVE, OR INTENDED TO DAMAGE THE REPUTATION OF ANOTHER ORGANISATION OR INDIVIDUAL.

AUTHORISED COMMUNICATION

OFFICIAL COMMUNICATION WITH OTHER CLUBS, ORGANISATIONS, COACHES, OR GOVERNING BODIES SHOULD ONLY BE CONDUCTED BY AUTHORISED ACADEMY REPRESENTATIVES, INCLUDING THE ACADEMY DIRECTOR OR DESIGNATED STAFF MEMBERS WHERE APPROPRIATE.

GYMNAST ENQUIRIES AND TRANSFERS

WHERE COMMUNICATION RELATES TO GYMNAST MOVEMENT, TRANSFERS, PATHWAY DISCUSSIONS, COMPETITIONS, OR PARTICIPATION OPPORTUNITIES, THE ACADEMY WILL AIM TO MANAGE COMMUNICATION PROFESSIONALLY AND IN THE BEST INTERESTS OF THE GYMNAST WHILST RESPECTING CONFIDENTIALITY AND GOVERNING BODY GUIDANCE.

CONFIDENTIALITY AND DATA PROTECTION

PERSONAL, SAFEGUARDING, MEDICAL, WELFARE, OR CONFIDENTIAL INFORMATION RELATING TO GYMNASTS, FAMILIES, STAFF, OR MEMBERS MUST NOT BE SHARED WITH EXTERNAL ORGANISATIONS UNLESS APPROPRIATE CONSENT, SAFEGUARDING REQUIREMENTS, OR LEGAL OBLIGATIONS APPLY.

SOCIAL MEDIA AND PUBLIC COMMUNICATION

MEMBERS, PARENTS, CARERS, STAFF, AND VOLUNTEERS ARE EXPECTED TO COMMUNICATE RESPECTFULLY ABOUT OTHER CLUBS AND ORGANISATIONS BOTH IN PERSON AND ONLINE. PUBLIC CRITICISM, DISPUTES, OR INAPPROPRIATE COMMENTARY INVOLVING OTHER ORGANISATIONS SHOULD BE AVOIDED.

GOVERNING BODY COMPLIANCE

ALL CLUB-TO-CLUB COMMUNICATION SHOULD ALIGN WITH THE EXPECTATIONS, REGULATIONS, AND PROFESSIONAL STANDARDS OF BRITISH GYMNASTICS AND ANY OTHER RELEVANT GOVERNING OR REGULATORY BODIES.
